

For native German speakers, finding the right translation, from German to English or vice versa, can sometimes be a challenge. Here are some examples to help you figure out how to say certain words. And to make sure you keep yourself out of trouble.

## Social or sociable?

Germans learning English tend to confuse *social* and *sociable*. Something *social* is an activity where individuals talk with other people or carry out activities as a team or in a group. *Social* describes someone who is extroverted or outgoing. *Social* can also describe things that have to do with society in general.

Sociable, however, means liking to be with and talk to other people, or enjoying friendly and pleasant social relations. For example, 'They are sociable people who like going to parties.' One easy way to distinguish between the two is to consider that social people like going out and being with people, while sociable people are easy for others to get along with.

## Prescribe or proscribe?

One letter can make a big difference. *Prescribe* and *proscribe* sound similar but have very different meanings. To *prescribe* is to recommend or dictate a rule for others to follow. To *proscribe* is to forbid or demand a stop to something.

Prescribe is often used at the doctor's surgery. When a doctor writes you a prescription, she prescribes medicine to heal you and make you better.

An easy trick to remember: think of the 'e' in *prescribe* for 'me' and the 'o' in *proscribe* for 'oh no, don't'.
